DELIVERY					
Packaged in 750ml polythene containers in a cardboard carton. Cardboard contains 6 x 750ml product.	Risk of spillage if the container is dropped. Risk of injury to user if dropped.	Trained employees should handle only single containers at any given time. Take care not to drop the containers. Ensure that the cap is secure at all times.	Transfer containers to store immediately following delivery to ensure secure storage of the product. Do not leave containers in areas where users of the building will come into contact with them. Ensure store cupboard is locked,		
STORAGE					
Do not decant. Store in original container in a dry, cool and dark place.	Minimal risk of spillage if caps are firmly in place. Caps are not child proof. Keep out of reach of children.	Ensure that the product is stored away securely product contains sodium hypochlorite. Keep containers in secure storage areas. Restrict access to storage areas to authorised personnel. Store away from acids.	Use oldest stock first. Make regular checks to ensure that storage area is clean and tidy. Make regular checks to ensure that containers are not split or blown.		
	USAGE				
Read the entire label before using product. N.B. Bleach can cause damage to many common materials. Do not mix with other cleaners. Keep separate from acids. Do NOT use on metal surfaces or mix with acids.	Contact with acids liberates toxic gas. Causes severe skin burns and eye damage. Harmful to aquatic life with long lasting effects.	Handle the containers with care. Ensure that the container is returned to store when not in use. Always read the manufacturer's instructions prior to use.	<ul> <li>Provide employees with PPE as follows:</li> <li>Protective glasses</li> <li>Protective gloves</li> <li>During prolonged or repeated use, or if contamination of clothing is likely, protective clothing should be worn</li> <li>Ensure that operatives are aware of location of First Aid facilities.</li> </ul>		
DISPOSAL					
Empty containers must be rinsed thoroughly and disposed of as normal waste. Residual stocks may be disposed of into a foul sewer (sluice) using plenty of water. Avoid release to environment. Recycle all containers wherever facilities are available.	If swallowed: rinse mouth. Do NOT induce vomiting. If on skin: Remove contaminated clothing immediately. Rinse skin with water/ shower. If inhaled: remove victim to fresh air and keep at rest in a position comfortable for breathing. If in eyes: rinse cautiously with water for several minutes. Remove contact lenses if present and possible to do so. Continue rinsing. Get immediate medical attention.	Wash out the container using plenty of water. Do not store any other material in the empty container. Ensure that the product is exhausted before disposal. Ensure that the product is not disposed of via a rainwater sewer (i.e. drain outside the building).	Ensure that all operatives wear personal protective equipment at all times.
