		DISPOSAL	
Empty containers must be rinsed thoroughly and disposed of as normal waste. Residual stocks may be disposed of into a foul sewer (sluice) using plenty of water. Recycle all containers wherever facilities are available.	Get medical attention if you feel unwell. Remove person to fresh air and keep comfortable for breathing if inhaled. After eye contact rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do so. Continue rinsing. If eye irritation persists: get medical advice.	Wash out the container using plenty of water. Do not store any other material in the empty container. Ensure that the product is exhausted before disposal. Avoid release to the environment. Ensure that the product is not disposed of via a rainwater sewer (ie drain outside the building). Handle empty containers with care because residual vapours are flammable.	Ensure that all operatives are aware of the First Aid equipment.
